It is the policy of the Evergreen Golden Retriever Club that the Show Chairman will not handle any dogs in any competitive class at the EGRC Specialty and that the Obedience Chairman will not handle any dogs in any competitive obedience class at this show. Family members of either chairman may handle dogs in any class, and dogs co-owned by either chairman may be shown if handled by someone other than such chairman. All other club members, including members of the Show Committee, are free to handle dogs in any class at this show.

The Show Chairman and Obedience Chairman for the GRCA Western Regional Specialty will conform to this policy regarding the Regional.



– NOTICE TO EXHIBITORS –

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- A RECORDING FEE will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This Recording Fee is to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Recording Fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2).
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.**
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Only dogs eligible for this show will be admitted into the show area. There is no provision for unentered dogs.
- The judging will start promptly. Dogs may arrive anytime prior to their time of judging, and may leave immediately thereafter, unless required for further judging.
- ENTRIES WILL BE ACKNOWLEDGED after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify the Superintendent at (360)683-1507 or email dogshows@dbamlg.com.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children on the day of the show.

Winners of the above classes, if otherwise undefeated,

BEST OF BREED COMPETITION: The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs that according to their owners records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

JUDGES AWARD OF MERIT: After awarding Best of Breed, Best of Winners, and Best of Opposite Sex, the Judge may present Awards of Merit (JAMS) to those dogs competing in the Best of Breed Class that are, in his/her opinion, outstanding specimens of the Breed. BOB, BOW and BOS are not eligible. Judge may award two JAMS or up to 10 percent of the Best of Breed entry, whichever is greater.

BEST PUPPY COMPETITION: To be selected from the first place winners in the Puppy Classes.

BEST VETERAN COMPETITION: To be selected from the first place winners in the Veterans Classes.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES:

STUD DOG CLASS – for Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class, and must be shown in the ring with their Get. The owner of Stud Dog need not necessarily be the owner of the Get. The Stud Dog may also be entered in one of the regular classes, or if a Champion of Record in Best of Breed Competition, however, there will be a fee of \$18 for the Stud Dog Class entry. The Get must be entered individually in one of the regular classes, Best of Breed, or some non-regular conformation class other than Stud Dog. Judging will be based on the merits of the Get.

BROOD BITCH CLASS – for Brood Bitches and two of their Produce. Same rules as Stud Dog Class. Note: As the judge's decision in the Stud Dog and Brood Bitch Classes are based on the merits of more than one dog/bitch, none of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won one of these classes.

SWEEPSTAKES AND VETERAN SWEEPSTAKES – BOTH SPECIALTIES

HANDLER: The handler of a Sweepstakes or Veteran Sweepstakes exhibit must be the owner, co-owner, breeder or member of their immediate family as they are listed on file with the American Kennel Club as of the closing date for the show for which the Sweepstakes entry is being made. To avoid confusion or question, it is recommended that a photocopy of the registration certificate be included with the entry for a co-owned exhibit.

PRIZE MONEY

Distribution of prize money for both Sweepstakes and Veteran Sweepstakes will be by the following schedule of the percent of the entry fees in each class:

NOVICE: This class shall be for boys and girls who are at least 10 years old and under 18 years old on the day of the show and who at the time entries close have not won three(3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN: This class shall be for boys and girls who are at least 10 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class in a licensed or member show, with competition present.

JUNIOR HANDLERS who win a third Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the third (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class. Junior Handlers who win a third Novice Class with competition present after closing of entries for a show may transfer their entry from Novice

Open Class provided that this transfer is made by the Show Secretary at least one half hour prior to the scheduled start of any regular conformation judging or one half hour prior to the schedule start of Junior Showmanship judging at the show, whichever is earlier.

JUNIORS PLEASE NOTE: All Junior Handlers are required to have an AKC number, contact AKC (212) 696-8281 or (212) 696-8240 for information. Also, all information required on both the front and back of the official AKC entry form must be included.

BITCHES IN SEASON ARE NOT ELIGIBLE in the Junior Showmanship Classes.

AT A SPECIALTY SHOW each dog must be of the breed for which the show is held. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the dog excused may not be handled in Junior Showmanship.

WINNING FIRST PLACE in an Open Junior Showmanship Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on the eligibility requirements for Limited Junior Showmanship Classes which have been approved by AKC, write to AKC, Show Plans, 51 Madison Ave., New York, NY 10010.

WALK-THROUGHS AND WARM-UPS

Handlers in all classes will be permitted to walk the course without a dog prior to the start of a class. At the judge's discretion, if the size of the entry for any class might inhibit a safe and fair walk-through by handlers, height divisions may be used to divide the walk-through into groups, e.g. walk-through for the 8", 12", and 16" division handlers followed by runs for those height divisions; then walk-throughs and subsequent runs for the 20" and 24" divisions. A warm-up area, consisting of a regulation agility jump, will be provided.

DOGS ELIGIBLE TO ENTER

This Trial is open to all dogs over the age of 12 months that are registered with the American Kennel Club or are registrable breeds that have obtained ILP numbers from AKC, except bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.

HEIGHT DIVISIONS

The following jump height division shall be used in all trial classes:

8 inches	for dogs 10 inches and under at the withers	4" Preferred class
12 inches	for dogs 14 inches and under at the withers	8" Preferred class
16 inches	for dogs 18 inches and under at the withers	12" Preferred class
20 inches	for dogs 22 inches and under at the withers	16" Preferred class
24 inches	for dogs over 22 inches at the withers	20" Preferred class

PLEASE INCLUDE A COPY OF YOUR JUMP HEIGHT CARD WITH YOUR ENTRY. ALL DOGS WITHOUT HEIGHT CARDS WILL HAVE TO BE MEASURED BY THE JUDGE.

OBSTACLES – Obstacles shall meet the specifications for obstacles in the current edition of AKC Regulations for Agility Trials. All jumps will be displaceable; Dog Walks with 12' or 8' foot planks will be used.

MOVE-UPS – Move-ups after entries close must be submitted to the Trial Secretary in writing by **NOON PDT on August 18, 2003**. The day to day move-ups will be accepted at the trial. Move-ups must be submitted in writing no later than 30 minutes after the trial ends each day.

CLASSES OFFERED

A complete set of rules for all classes is available from the American Kennel Club, 5580 Centerview Drive, Suite 200, Raleigh, NC 27606, or from the AKC web site. It is the exhibitor's responsibility to enter their dog in the correct class. The Trial Secretary cannot make any changes (except for move-ups as noted) after the closing date of the trial. Be sure to check your entry form carefully and make certain you have entered the correct class(s). Standard Agility and JWW class descriptions:

- **Novice** – is divided into Division A for persons and dogs that have never acquired an agility title, And Division B for dogs that have acquired the Novice Agility title, persons who have handled a dog to an agility title, and for agility judges.
Note – if you have a title in JWW you may not show in Novice A in Standard and vice versa.
- **Open** – Open to dogs that have acquired the Novice Agility or Open Agility titles but which have not acquired the Agility Excellent title.
- **Excellent Class A** – is open to dogs that have acquired the Open Agility title and to dogs that have not acquired the Agility Excellent title.
- **Excellent Class B** — is open to dogs that have acquired Agility Excellent title.

NEW!! PREFERRED CLASS INFORMATION

The Preferred Class is a new titling program offered by AKC starting September 1, 2002. This class offers a longer Standard Course Time and lowered jump heights. Preferred Classes will be held immediately before or immediately after the Regular Classes, on the same courses. All dogs entering the Preferred Classes for the first time must enter the Novice level in both the Preferred Standard Agility Class and the Preferred Jumpers with Weaves Class regardless of their previous title level in the Regular Classes. (Standard and JWW). There is no “grandfathering” of titles from the Regular Classes to the Preferred Classes or from the Preferred Classes to the Regular Classes. These classes are separate titling programs and in both cases the dogs must start at the Novice level. Dogs may be entered in only one (1) Standard Agility class and one (1) Jumpers With Weaves Class per day, i.e. they cannot simultaneously compete in both Regular and Preferred for the same class. A dog may continue to compete at each level until they achieve a qualifying score at the next higher level. The Preferred Standard Agility Class and the Preferred JWW Class are separate titling programs and a dog may advance faster in one than the other (A dog that has achieved its NJP is eligible for and may enter the Open Jumpers With Weaves Preferred Class. The same dog must also achieve three (3) qualifying scores in the Standard Novice Agility Preferred Class before being eligible to move-up to the Standard Open Agility Preferred Class). In order to acquire a Preferred Agility title, a dog must earn the required qualifying scores per Preferred Class level under at least two (2) different judges. Grandfathering is no longer in effect in Jumpers With Weaves. To be eligible to compete in an advanced class. The dog must have earned a title in a lower level class, UNLESS he earned a leg in the more advanced class before October 31, 1998.

IMPORTANT INFORMATION FOR EXHIBITORS

Conditional, unsigned, incomplete, illegible, telephone or telegraph entries cannot be accepted. Entries not on official AKC form or photocopies of AKC forms without the agreement and rules on the reverse side of the official AKC entry form are not acceptable.

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, or in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. No entry fee will

be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of public enemy, or any other cause beyond the control of the organizing committee.

Confirmation of entry and schedule of judging time will be sent to the address of the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, contact the Trial Secretary. Returned checks do not constitute a valid entry.

The **Golden Retriever Club of America and the Evergreen Golden Retriever Club** assume **No** responsibility for any loss, damage or injury sustained by exhibitors, handlers, or spectators, or to any of their dogs or property, and further assumes no responsibility for injury to any child not under the control of his or her parents or guardians.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the Trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Food and toys are not permitted in the course area and handlers are not permitted to use whistles or other instruments or devices.

The safety of dogs is of primary concern. 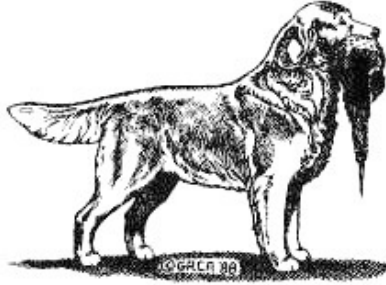
