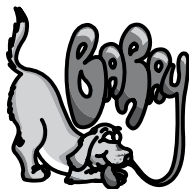

The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

AWARD OF MERIT

The Regular Class Judge, may, at his/her discretion, present an Award of Merit Rosette to no more than three (3) Dogs and/or Bitches who have competed in the Best of Breed judging at this Specialty. Best of Breed and Best of Opposite Sex are not included in the three Awards.

NOTICE TO EXHIBITORS REGARDING CORRECTIONS OR CHANGES TO ENTRIES: Corrections other than the specific changes listed in Ch. 11, Sec. 6 (i.e. sex of a dog, transfers between age specific classes, and "move-up's" to BOB or BOV) are the only changes to the entries superintendents or secretaries are authorized to make after closing of entries. Owners are responsible for errors in the entry forms, regardless of who may make such errors. **THIS RULE IS BEING STRICTLY ENFORCED BY THE AMERICAN KENNEL CLUB. – NOTICE TO EXHIBITORS –

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- Effective for all events held on and after January 1, 2008, The American Kennel Club will collect a \$3.00 Event Service Fee for the first entry of a dog and a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC licensed and member club events. The current 50 cent recording fee will continue to be collected. The event-giving club shall assume the responsibility of collecting all Event Service Fees for The American Kennel Club. These event service and recording fees shall be forwarded to The American Kennel Club along with all other required event results within seven (7) days of the close of the event.
- **CANADIAN CHECKS OR MONEY ORDERS MUST BE MADE PAYABLE IN U.S. FUNDS.**
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor BaRay Event Services will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club and/or BaRay Event Services assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR THE COMPLETENESS OF ENTRY RESTS SOLELY WITH THE ENTRANT.**
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly.
