Non-Regular Classes Involving Single Dog Entries

Because WINNERS of these classes will compete for Best of Breed, all entrants MUST also meet ALL American Kennel Club requirements for Non-Regular Classes involving single dog entries. NOTE: Any placement other than First in any of these classes eliminates the dog from competing in Best of Breed Competition.

*Veteran Dogs, 7 Yrs. & under 10 Yrs.

*Veteran Bitches, 7 Yrs. & under 10 Yrs.

*Veteran Dogs, 10 Yrs. & under 12 Yrs.

**Chapter 11, Section 8: of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Veteran Dog in the Veteran Dog Class and a spayed bitch may be entered as a Veteran Bitch in the Veteran Bitch Class.*

Best of Breed Competition – The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs according to their owner's records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

Award of Merit – At the conclusion of Best of Breed, after picking Best of Breed and Best of Opposite Sex to Best of Breed, Select Dog and Select Bitch, the Specialty Judge at his/her discretion may award Rosettes for Awards of Merit to a maximum of 10% of the Best of Breed entry.

Best Puppy from the Regular Puppy Classes – After Best of Breed, the first place winner of each of the four puppy classes will compete for Best Puppy. The 12 months and under 18 months classes are not considered a puppy class.

Best Veteran – After Best of Breed, the first place winner of each of the six veteran classes will compete for Best Veteran.

SPECIAL NOTICE – CLUSTER OBEDIENCE TRIAL & CLUSTER RALLY TRIAL

With the approval of the American Kennel Club, Obedience and Rally Trial classes at the OKC cluster will be consolidated to provide maximum efficiency in scheduling and judging. The Judging Program will include a complete list of breeds to be judged, and the order in which they will be judged. All Specialties in this Cluster that are offering Obedience Classes will be judged together. Each dog will be judged and individual scores recorded in the respective breed's judge's book. For the group exercises in Obedience, all breeds will be judged in one group. If there are more dogs competing than can be spaced four (4) feet per dog on one side of a ring, some must be judged in another group. The judge will divide the class into equal sections and the group exercise will be judged after each section. Following completion of group exercises, the judge will complete the judge's books for all dogs entered in each Obedience class in the respective breed's judge's book. Ribbons and awards will then be awarded by breed. Qualifying points in Obedience are based on the number of dogs in each breed only. All Specialties in this Cluster that are offering Rally Classes will be judged together. Each dog will be judged and individual scores recorded in the respective breed's judge's book. The judge will complete the judge's books for all dogs entered in each Rally class in the respective breed's judge's book. Ribbons and awards will then be awarded by breed.

OBEDIENCE & RALLY EXHIBITORS: MOVE-UPS WILL BE ACCEPTED ACCORDING TO CH. 1, SEC. 16, OBEDIENCE REGULATIONS.

ROUTES TO THE SHOW

FROM THE NORTH OR SOUTH ON I-5 - Take the Auburn Exit (Highway 18). Go to Auburn and take the Enumclaw Exit to Highway 164. Follow the signs to Enumclaw (Highway 410), just before Enumclaw, turn right on 244th, go to 456th and turn left. It becomes Warner. Stay on Warner to the fairgrounds.

GOING SOUTH ON I-405 OR COMING FROM THE RENTON AREA - Go east on Maple Valley Highway (Highway 169), go through Black Diamond, continue on until 416th SE, turn left, then follow signs to the fairgrounds.

- Set up of tents/equipment may not be within 15-ft of any rings. This will be enforced.
- There will be NO loading or unloading of crates/dogs at ring side during show hours! Loading and unloading will be at the Livestock Barn **ONLY on Friday – gate opens at 6:00am**. Grooming will be available in the Livestock and Horse Barns.
- **No vehicles will be allowed on the show grounds after 7:00am on Friday unless they have reserved parking.**
- There will be NO day parking on the fairgrounds.
- Overnight parking will be handled by J.I.F.Y.S. See rules, Page 11. Day parking is \$5 per day.
- Power Outlets – Use of ALL power outlets is at user’s own risk.
- No practicing allowed in rings at any time.
- No dogs to be left overnight in grooming building.
- Each exhibitor is responsible for cleaning up after his own dog(s). Pooper-scoopers will be placed around the show grounds for your convenience. If your dog soils in the show ring, the ring steward will hold your dog while YOU do the clean up. A pooper-scooper will be placed outside each ring. Responsible dog owners will clean up after their dog(s).
- PARENTS SHALL BE RESPONSIBLE FOR THEIR CHILDREN AT ALL TIMES!
- NO SKATEBOARDS, ROLLERBLADES, SCOOTERS OR BIKES WILL BE ALLOWED ON THE SHOW GROUNDS.
- Grooming and exercise pens in DESIGNATED AREAS ONLY. Crates may be brought to ringside during breed judging and must be removed immediately when judging for that breed is over.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present in the Novice class. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form. **SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S):**

There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

SWEEPSTAKES AND VETERAN SWEEPSTAKES

HANDLER: The handler of any sweepstakes exhibit must be either the owner, co-owner, breeder or member of their immediate family as they are listed on file with the American Kennel Club as of the closing date for the show for which the sweepstakes entry is being made. Immediate family is defined as husband, wife, mother, father, brother, sister, son, daughter or legal domestic partner. Step children and legal wards are also included in this definition. In-laws and grandchildren are not considered to be immediate family members. No other individual may take the entry into the ring during judging or check-in.

The following individuals are excluded from showing an exhibit in sweepstakes unless they are the sole owner registered with the AKC or co-own the entry with a member of their immediate family (as defined above) or a legal domestic partner:

- Any individual listed as an Agent on any dog in any regular or non-regular class at this or any other show in the previous two years.
- Any individual with an Agent number including, but not limited to, an AKC Registered Handler Number or Professional Handlers Association (PHA) number.

To avoid confusion or question, it is recommended that a photocopy of the registration certificate be included with the entry for a co-owned exhibit.

Disabled or physically challenged handlers are encouraged to show their own dogs and every effort will be made to accommodate them.

Best in Sweepstakes Classes: It is required that the same person who showed the dog to a first place in a sweepstakes class will also show the dog in the Best in Sweepstakes class. However, if that person should have more than one dog in the Best in Sweepstakes class, someone else is permitted to show the additional winner. That person should meet the handler definitions above. Only in cases where there is not another owner, co-owner, breeder, co-breeder or immediate family member available, should another person take the dog into the Best in Sweepstakes class. It is understood that there would be no financial benefit to that individual. Individuals who have an AKC Handler number, a PHA number or are listed as Agent on any dog in the regular or non-regular classes may not show a sweepstakes entrant unless they are the sole owner registered with the AKC or co-own the entry with a member of their immediate family (as defined above) or a legal domestic partner.

ENTRIES: Entry Fee is \$24.00. Entries must be made at the same time and on the same official AKC entry form as the regular classes, indicating in the space titled "Additional Classes" the Sweepstakes entry and age division.

PRIZE MONEY: Distribution of prize money will be by the following schedule of the percent of the entry fees in each class:

35%	Host club to cover expenses
20%	Best in Sweepstakes
15%	15% .. Best of Opposite Sex to Best in Sweeps
15%	7.5% .. Second place in each class
5%	2.5% .. Fourth place in each class
5%	Third place in each class

Undistributed funds revert to the Club. All Cash Prizes are rounded to the nearest dollar amount.

SWEEPSTAKES

ELIGIBILITY: Any purebred Golden Retriever six months of age and under eighteen months of age and entered in any of the regular classes at the specialty show at which the Sweepstakes are held. Dogs which have completed the requirements for an AKC Championship (according to AKC records) prior to the closing date of the show at which the Sweepstakes are to be held are not eligible.

CLASS DIVISIONS: Class divisions shall be the same for dogs and bitches.
